### Privacy Content

#### 1.1 Terms and Conditions

- a) This app does not require a registered account and will not collect personal information. It only requires camera permission and fingertip light for heart rate calculation.
- b) When using the web service, information such as IP address, browser type, language used, date and time of access, and web page records may be automatically collected.
- c) User personal data obtained legally from business partners.
- d) The application is recommended for users aged at least 3 and under 13 under adult supervision.

You acknowledge that certain information is not covered by this Privacy Policy:

- a) Keyword information entered during the search service.
- b) Information collected by [Platform] about participation, transactions, and evaluations.
- c) Violations of the law or [Platform] rules.

#### 1.2 Information Use

- a) [Platform] will not offer, sell, rent, share, or trade your personal information without permission.
- b) Third parties are prohibited from collecting, editing, selling, or distributing personal information.
